Our team of over 250 home care aides provides quality care to a diverse older adult population speaking languages that include Cantonese, Mandarin, Croatian, Vietnamese, Tagalog, Burmese, Nepalese, Laos, Bosnian, Khmer, Taishanese, Hindi, and Serbian. Our caregiving team comprises of more than experienced 250 home care aides and 16 staff members.

CMAA is a member of the Illinois Association of the Community Care Program Homecare Providers (IACCPHP) and a member of the IDoA's Community Care Program Advisory Committee (CCPAC). Our Director of the Elderly Care and Social Services serves on the CCPAC and IACCPHP Board to advocate for the older adults served, home care aides, and providers. Together as an organization, our Executive Director and program staff members consistently engage in evaluating and providing recommendations to enhance the quality of the Community Care Program state-wide through advocacy.

We are currently in the process of developing and rolling out In-Home Services for older adults who are not eligible for Medicaid benefits. Older adults who need assistance in their homes but have incomes exceeding the low-income guidelines can request services through our Private Pay program. Since 1997, CMAA has offered citizenship and immigration legal services to low-income immigrants and refugees seeking to apply for U.S. citizenship and other benefits. Our Department of Justice (DOJ) accredited staff offered individualized legal counsel and case assistance at a low cost to clients and, often, in their native languages of Vietnamese, Cantonese, or Mandarin. In FY21, CMAA assisted 165

clients apply for citizenship and prepare for the naturalization exam, and over 60 clients reunite with their families abroad, obtain green cards, apply for work authorization, or seek counsel for other immigration-related issues.

Adult Education:

Through a grant from the Illinois Community College Board, CMAA and its partner agencies - the largest and most diverse consortium in the State of Illinois - offered English as a Second Language (ESL) and Civics classes to over 600 limited English Proficient (LEP) immigrants and refugees across the City of Chicago in FY21. Partners included such agencies as the Ethiopian Community Association of Chicago, Hanul Family Alliance, Indo-American Center, and Muslim Women Resource Center, among others. In FY21 our consortium offered Adult Basic Education classes, in addition to ESL classes, in order to help clients with higher level English improve their reading and math skills. Additionally, through the support of the Illinois Community College Board, CMAA continued to offer ESL classes in Elgin, Illinois, a new service CMAA launched in FY18. In Chicago, CMAA offered classes at local Chicago Public Schools for parents. Our adult education classes helped prepare students to participate fully in their communities, and covered such topics as: the rights of immigrants and U.S. citizens, U.S. history and governance, accessing community resources, consumer economics, and workforce readiness skills. In FY21, with the support of the Illinois Community College Board, CMAA continued our Healthcare Employment Preparation Program in both Chicago and Elgin. CMAA offered contextualized Healthcare Literacy classes and holistic case management to participants. The class supports English Language Learners who are interested in pursuing a career in healthcare; the program focuses on increasing students'

employability skills, English reading and writing skills, and prepares students for entering a career within the healthcare industry or pursuing further educational opportunities. Furthermore, with support from the Secretary of State, CMAA was able to serve limited English proficient adult students, unable to attend classes, by matching them with volunteer literacy tutors. Throughout the COVID-19 pandemic, our agency and partners served students safely through virtual classes. In order to address the digital divide, CMAA was able to lend our laptops to our students for classroom use through funding by the Illinois Community College Board.

Employment:

CMAA career coaches provided individualized employment preparation, referrals, and job placement assistance to unemployed or underemployed community members. Our clients represent diverse professional backgrounds, such as healthcare, hospitality, and industrial work, and have various levels of education. Although CMAA primarily serves immigrants and refugees, our Workforce Development Program also attracts U.S.-born Americans who need assistance with job readiness training, resume writing workshops, and digital literacy support. In calendar year 2020, we served approximately 117 unique clients, helping all clients become prepared for employment through a series of employment readiness activities, including career skills assessments, and the creation of an Individualized Employment Plans. Our career coaches meet individually with all clients to address barriers and challenges to employment. Our reputation as a provider of quality, hardworking employees has helped create a network of employer partners, such as Weiss Memorial Hospital, O'Hare International Airport, and the Viceroy Chicago, who regularly contacted CMAA for staffing needs.

Social Services:

CMAA's social services department works with the Illinois Department of Human Services (IDHS) to break down language and cultural barriers to help low-income clients and families identify and access benefits that are available to them through local, state and federal programs. In fiscal year 2020, our direct service staff assisted over 800 families in applying for All Kids, SNAP, Medicaid, TANF and other public benefits. In addition, staff helped 1000 low-income families and individuals apply for energy assistance to offset winter heating and summer cooling costs through the low-income heat and energy assistance program (LIHEAP). Furthermore, our housing services assisted clients with finding affordable and subsidized housing, providing assistance in understanding leases and foreclosures, and helping resolve tenant-landlord conflicts. COVID relief programs like rental assistance and cash assistance benefitted around 200 families.

Youth Department:

CMAA's Youth Department was founded to serve immigrant, refugee, and BIPOC youth on Chicago's far northside after CMAA identified a lack of support and services for low-income immigrant youth populations in our community, who are often under-resourced, marginalized, and at high risk for social isolation. Our youth programming addresses this dearth and builds youth leaders by supporting the academic and professional development of economically disadvantaged immigrant youth and youth of color through academic enrichment, exposure activities, extracurriculars, mentorship and recreation. In total, CMAA's Youth Department serves over 150 young people annually, working with students beginning in kindergarten all

the way through adulthood.

CMAA's largest youth program, Diverse Young Leaders, provides after school academic enrichment, career exposure, and recreational activities for youth from kindergarten to 8th grade. Programming includes homework help, specialized tutoring, recreational activities, service learning, and other extracurricular activities. In fiscal year 2021, after school staff worked tirelessly to provide individualized tutoring to combat the widespread learning loss as a result of virtual learning during the pandemic. As a result of our efforts, in the 2020-2021 academic year, 76% of our students earned a 3.0 GPA or higher. In the 2021-2022 academic year, CMAA will focus on academic enrichment and social emotional learning to ease the transition back to in-person learning after a year of isolation due to learning from home without their peers.

When school is not in session, our after school programming transitions into CMAA's popular Youth Summer Camp program, which meets weekdays for all of July and August from 9 a.m. to 4 p.m. CMAA's summer programming focuses on academics, life skills, community service, and youth development through recreational activities and play. Activities include weekly academic lessons to aid in grade transition; daily recreational instruction to enhance team-building skills and mental and physical health; financial literacy; and monthly field trips.

CMAA's suite of teen programs focuses on youth employment, college and career readiness, and teen mentorship. In fiscal year 2021, our agency served 30 teens per year through paid employment and training opportunities. CMAA's teen interns work with our agency to facilitate youth recreational and health activities, and provide

tutoring and test prep to students in the Diverse Young Leaders and Youth Summer Camp program. Through their participation, interns learn important 21st century skills such as verbal communication, collaboration, and problem solving. CMAA's teen mentorship programs include our young women's mentoring group, Young Women Warriors (YWW), and our young men's mentoring program, Young Men Making Moves (YMMM). The YWW program has been a prominent community service for over 20 years and brings young women ages 12 to 18 together with older female mentors that are successful leaders and role models in their community. The YMMM was formed after seeing a gap in services for supporting first and second generation male youth. Both mentoring programs provide college and career readiness, foster leadership skills, and build social emotional competencies. This process occurs through a combination of workshops, which focus on key skill sets, and activities, or outings that provide a platform for our mentors and mentees to deepen their relationships. Past workshops include public speaking, college scholarships, interviewing, female health, financial literacy, and civic engagement. Activities include kayaking, rock climbing, and metal-working. All of the mentees CMAA serves in these programs are first generation Americans, and the vast majority (95%) will be the first in their family to go to college. In fiscal year 2021, 100% of mentees reported that they feel their mentors care about how they're doing in school and in the future. In addition, over 80% indicated they feel comfortable talking to their mentors when something makes them feel "angry or afraid," indicating the strength of the relationships our mentees and mentees have with each other.

Finally, CMAA's youth department currently oversees Tiger Tutor, our agency's first social enterprise initiative. A test prep and tutoring program, Tiger Tutor focuses on individualized, high quality instruction to help students achieve their academic

and collegiate goals, and currently provides small group tutoring, one-on-one instruction, and college advising. Tiger Tutor helps students while successfully helping CMAA diversify its revenue streams, ensuring our agency is able to continue to provide vital social services to our community.

Illinois Small Business Development Center at CMAA:

The SBDC program is the largest federally designated technical assistance program focused on supporting startups and growing small businesses in all fifty states and U.S. territories. The primary purpose is to provide information, training, and guidance to assist and accelerate the growth potential of viable, long-term, entrepreneurial ventures, small businesses and start-up businesses to create and retain jobs in Illinois. The vision of the Illinois SBDC program is to be recognized as the leading resource for business growth, advancing the Illinois economy. Every center within the program works to achieve this mission by providing professional guidance for business growth. Chinese Mutual Aid Association was designated to be a new Illinois Small Business Development Center in June 2020 and during 2020 advised 47 small business clients of whom 66% are minority clients.
